**Third**, we plan to **expand** and operate the service targeting countries with similar situations to Korea.


# Critical Thinking & Problem-Solving

Over a period of 10 years, the number of Korean lawyers has tripled, but the number of cases has decreased.

In a saturated lawyer market, we thought that we needed a way for lawyers to take on more cases with less effort and time. We realized that they needed the right tools

Therefore, we thought of **Chat AI technology** as a way to efficiently search for similar precedents and provide accurate and easy access to necessary information.


Eliminating the existing tedious keyword-based search process for similar precedents, we conceived of a function that makes it easy to see similar precedents if detailed situation in inputted.











### Meeting An Unmet Need

As a result of a survey, 224 out of 243 lawyers felt an improvement in the search for legal precedents, which is 92.1%

Of those, 73% indicated that they would be willing to adopt Fence.

In addition, of those who participated in the survey 46.3% said they could spend an average of 500,000 won to 700,000 won per month.



Furthermore, FENCE will expand its business

domestically and advance into the world. Through conversations with overseas legal tech experts at the Stanford CODEX meeting, we confirmed that solo litigation is not just a Korean problem.

We will translate the website and litigation guide service into various languages to attract overseas litigants as consumers, and will establish a precedent-matching service that overseas lawyers can use.


